- Has the bidder supplied references or stated his/her experience as a Company to undertake the contract. References of past experience must accompany the bid document.
- c. The financial standing of the bidder and ability to render a service may be examined before an award of bid take place.
- d. Preferences will be taken into consideration by the Department in terms of the B-BBEE Scorecard.
- e. Documented reports received from an institution/s pertaining to past bad performance by a company who is tendering, may be taken into consideration.
- f. Did the bidder attend the site inspection?
- g. Will the bidder be in a position to successfully execute the contract?
- h. The 80/20 Point System will apply in the evaluation of this bid.

#### 3.18 IRREGULARITIES

2.18.1 Companies are encouraged to advise the Department timeously of any possible irregularities which might come to their notice in connection with this or other contracts.

#### 3.19 JOINT VENTURES

- 3.19.1 In terms of the Supply Chain Management Policy Framework, a consortium or joint venture may, based on the percentage of the contract value managed or executed by respective members.
- 3.19.2 Should this bid be submitted by a joint venture, a certified copy of the joint venture agreement <u>must</u> accompany the bid document before the closing date and time of bid. 3.22.1 Should the services not be rendered to the satisfaction of the Department and unsatisfactory items/ aspects/ events have already, in writing, been brought to the attention of the Contractor, the Department reserves the right in terms of paragraph 3.27 hereunder, to retain payment to the Contractor for as long as the unsatisfactory service continues.

#### 3.23 CENTRAL SUPPLIERS DATABASE

#### 3.25 TERMINATION OF SERVICES

# APPOINTMENT OF A PANEL OF SERVICE PROVIDERS TO BE APPOINTED TO RENDER SECURITY SERVICES TO THE DEPARTMENT

#### 1. SERVICE

The Department of Co-operative Governance and Traditional Affairs wishes to appoint a panel of service provider for a period of thirty six (36) months to provide security services to the Department's premises.

#### 2. TERMS OF REFERENCE

- 2.1 The Service Provider shall act as an Authorized Officer in terms the Control of Access to Public Premises and Vehicles Act, 1985 (Act No. 53 of 1985).
- 2.2 The Service Provider must follow the procedures of the Criminal Procedure Act, 1977 (Act No. 51 of 1977) in particular sections 20, 23, 24, 29, 42, 49, 50 and 51 when it search the premises, seize an article or arrest a person.
- 2.3 The Service Provider must control access and egress to the premises -
- 2.3.1 to prevent unauthorised access and egress of persons and vehicles onto the premises;
- 2.3.1 to prevent persons from bringing dangerous objects onto the premises;
- 2.3.3 to prevent unauthorised removal of persons, assets, documents and other information from the premises; and
- 2.3.4 to prevent property against damage and vandalism.
- 2.4 The Service Provider must ensure that no state property or information is removed from the premises without the authorisation issued by a person designated by the Department to authorise the removal.
- 2.5 The Service Provider must ensure that no state owned vehicle is removed from the premises without a completed and approved trip authorisation issued by a person designated by the Department to grant trip authority.
- 2.6 The Service Provider must ensure that no dangerous objects, including firearms, are allowed onto the premises. If no secure storage facilities are available on the premises, the owner of the dangerous object must be referred to the nearest station of the South African Police Service (SAPS)
- 2.7 Access control must be applied at the following points –
- 2.7.1 all vehicles entrances;
- 2.7.2 all pedestrian entrances;
- 2.7.3 any other place on the premises required by the Head of the Department or his or her authorised representative.
- 2.8 The Service Provider must keep an access control register to keep a record of all staff that cannot produce a staff identity card and visitors. The access control register must be clearly legible. The following information must be recorded in the register —
- 2.8.1 the person's name and surname;
- 2.8.2 a contact number for the person;
- 2.8.3 the name and a contact number for the person that he or she is visiting:
- 2.8.4 the time of arrival on the premises;
- 2.8.5 the time of leaving the premises.
- 2.9 The Service Provider must record any staff entering or leaving the premises in the afterhours access control register –
- 2.9.1 on a work day before 07h00 or after 16h30; and
- 2.9.2 any time on week-ends and public holidays.

- 2.10 The Service Provider may not allow entry of any non-staff after hours, week-ends or on public holidays.
- 2.11 The Service Provider must keep a register of the serial numbers of all laptops that are brought into the building or that leave the building.
- 2.12 The Service Provider must keep a record of all vehicles that enters and leaves the premises. The Service Provider must record the number plate, make and model of all vehicles that are not privately owned vehicles of staff that are stationed at the premises in addition to the information in paragraph 2.8 in an access control register.
- 2.13 The Service Provider must inspect all vehicles to ensure that no state owned assets are removed from the premises without the necessary consent.
- 2.14 The Service Provider must conduct patrols in the following manner -
- 2.14.1 a patrol must be carried out at least once every hour;
- 2.14.2 patrols must be carried out in the following areas -
- 2.14.2.1 vehicle parking;
- 2.14.2.2 inside the buildings; and
- 2.14.2.3 along the outside perimeter of the buildings
- 2.14.3 the security officer on patrol must -
- 2.14.3.1 check that all exterior doors are locked after hours, week-ends and public holidays.
- 2.14.3.2 report any broken windows in writing to the Head of the Department or his or her authorised representative;
- 2.14.3.3 report any external lights not illuminated during hours of darkness to the Head of the Department or his or her authorised representative;
- 2.14.3.4 record the number plate and make and model of all vehicles that are parked overnight at the premises in the occurrence register;
- 2.14.3.5 record any irregularities in writing in the occurrence register, including –
- 2.13.3.5.1 the nature of the irregularity:
- 2.13.3.5.2 the time that the irregularity was recorded in the incident register; and take appropriate action.
- 2.15 This radio base station must be operational at all times and must be linked to a manned security centre of the service provider. The Service Provider must ensure that there is 24 hour communication between the security company office and all the premises that are guarded by it
- 2.16 The principle of minimal force will apply at all times to the use of firearms which must be carried with minimum visibility.
- 2.17 The Service Provider must ensure that no security officer carries his or her personal firearm.
- 2.18 In times of unrest the Service Provider must secure the entrance gates to the premises against any illegal incursions.
- 2.19 The Service Provider must conduct a quarterly risk evaluation of the premise which must be submitted to the Head of the Department or his or her authorised representative.
- 2.20 Any other condition that might be deemed to be required by the Department.

#### 3. EQUIPMENT REQUIREMENTS

3.1 The Service Provider must supply and maintain the following security equipment at its own cost –

- 3.1.1 handheld metal detectors at all access control points.
- 3.1.2 handheld radios that are compatible with the base radio station;
- 3.1.3 a radio base station installed at the premises;
- 3.1.4 rechargeable flashlights with four (4) cell capacity;
- 3.1.5 registers and associated stationary;
- 3.1.6 fire arms, ammunition, handcuffs and batons; and
- 3.1.7 any other security related equipment that maybe required by the Department.
- 3.2 Security guards must be dressed in neat and clearly identifiable uniforms from the Service Provider, including raincoats and overcoats for rainy and cold conditions.
- 3.3 Security guards must be provided with an identification card from the Service Provider which must include the security guard's photo, identification and file numbers and be worn conspicuously on his or her person at all times.

#### 4. CONTRACTUAL LIABILITY

- 4.1 If the Service Provider fails to deliver any of the services within the contact period the Department shall, without prejudice to its other remedies under the contract, deduct from the contract price or performance security as a penalty, a sum calculated on the delivered price of the service that was not provided. The Department reserves the right to terminate the contract, if the Service Provider is unable to provide any of the services for a prolonged period or if any of the services is provided erratically for a prolonged period.
- 4.2 The Service Provider shall be contractually liable for any damage to or the loss of any state owned asset that is damaged or lost, including due to theft by a third party, as a result of negligence by the Service Provider during the contract period.
