BACKGROUND TO NATIONAL SPLUM FORUM

- National Coordinating Forum (NCF) established by DRDLR as a consultative forum in the development of SPLUMA.
- Dealt with general spatial planning matters affecting provinces and municipalities.
- Prior to SPLUMA commencement focused on SPLUMA **Implementation Readiness**, Finalisation of **Regulations** and **National Projects**.
- NCF role now being redefined to address emerging challenges of implementation and also to deal with general Spatial Planning and Land Use Management issues.

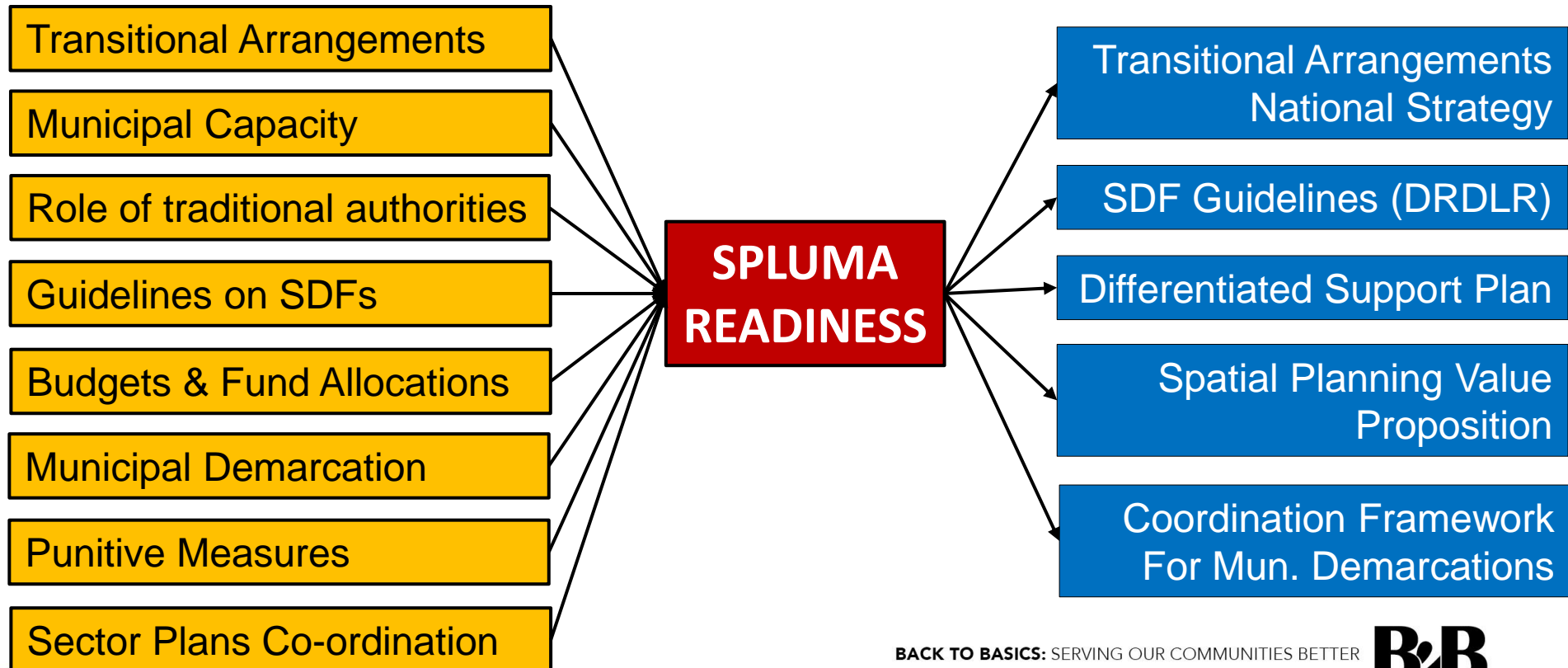
