PDA Section 26(6) vs Section 60(1)(c)


- Section 26(6) used to correct an error in the wording
- Section 60(1)(c) alter suspend or delete a condition of approval for the subdivision or consolidation of land.
- Solution:-
 - Ask applicant to submit proposed condition of establishment
 - Send conditions to applicant before they officially go out

Road Closures

- Municipalities still using the PDA
 - Will use section 211 and 212 of the Local Authorities
 Ordinance (25 of 1974)
 - If the road closure results in an amendment to a GP municipalities must apply to COGTA for consent ito Section 37(2) of the Land Survey Act
 - LUM with support from Legal will have this Section delegated to Municipalities

Road Closures

- Municipalities using SPLUMA By-Laws
 - Section 211 and 212 of the Local Authorities Ordinance (25 of 1974) has to be complied with, <u>irrespective</u> of whether or not a municipality has a planning by-law
 - If the road closure results in an amendment to a GP municipalities must apply to COGTA for consent ito Section 37(2) of the Land Survey Act
 - LUM with support from Legal will have this Section delegated to Municipalities

- Some key dates for KZN
 - 18 June 2010 Constitutional Court declared Chapters 4&5 unconstitutional Suspended for 2 years
 - 17 June 2012 all unfinished business had to be completed but decisions could be appealed or reviewed
 - No extension of time can be granted after the 17 June 2012 1 July 2015

- Is your DFA alive or not
 - It was always thought that the gazetting of the DFA tribunals decision became effective when it appeared in the gazette (Clock started)
- Regulation 23(1) when an applicant "has been notified"...... has 5 months to lodge for approval with the SG.....lapse
- Regulation 23(10) within 2 months after the GP's were approved by the SG the applicant must lodge GP with DO, Local Gov. body and Registrar of Deeds......lapse

- Is your DFA alive or not
 - Section 43(2) of SPLUMA "A conditional approval of an application lapses if the conditions are not complied with within
 - (a) a period of 5 years from the date of such approval
- If my DFA is gazetted but I have not submitted the GP's to the SG within the specified 5 months- has it lapsed??
- If my DFA is gazetted and I have submitted the GP's to the SG within the specified 5 months- but not to the Registrar of Deeds within 2 months- has it lapsed??
- If my DFA is gazetted and has lapsed because of one of the above does the rezoning lapse as well??

- Some key dates for KZN

 - Section 60(2)(a) brings alive dormant DFA applications
