

1. Background & Purpose

- The purpose of working group (4) has been to develop a SPLUM Capacity Building Strategy that will respond to experiences and challenges that are currently faced by municipalities in becoming SPLUMA compliant.
- A need list analysis and SPLUMA Training need assessment template comprised of questionnaire schedules was agreed upon in the forum, this is and has been distributed to municipalities for inputs.
- The aim is to establish backlogs and pending SPLUMA interventions and to be informed by what exists rather than presumptions when it comes to municipal SPLUMA BACK TO BASICS: SERVING OUR COMMUNITIES BETTER readiness.



2. Identified Capacity Building Interventions

- MPTs
- Appointed AOs on their roles and responsibilities
- Municipal Councillors
- Private sectors to understand SPLUMA procedures for processing applications
- Traditional Authorities- on SPLUMA requirements to start now to work with municipalities & planners when it comes to land allocations in areas of their jurisdictions

4. Timeframes Set by the National SPLUM Forum to Implementing the Strategy

- First draft of the National SPLUM Capacity Building Strategy to be completed by 31 July 2016
- Draft will then be work shopped with all members of the National Working Group 4 in August and September
- Final will be ready for adoption by the National SPLUM Forum in October.
- National SPLUM forum is a forum composed of all members of GR 1-4.
- Once adopted, this then will be implemented in respective municipalities per province but guided by the circulated template BASICS: SERVING OUR COMMUNITIES BETTER





3. SPLUMA Implementation Team in KZN

- Department of Rural Development and Land Reform is ensuring that the by-laws are advertised for comments and adopted by council.
- COGTA is ensuring that institutional structures are established and that municipalities understand the new requirements of Land Use Schemes and Spatial Development Frameworks in terms of SPLUMA
- SALGA is ensuring that councillors understand their roles and responsibilities with regard to appeals.
