Failure to submit the joint venture Agreement will result in preference points not being allocated to all companies participating in the joint venture.

3.20 LATE BIDS

- 3.20.1 Bids are late if they are received at the address indicated in the bid documents after the closing date and time.
- 3.20.2 A late bid shall not be considered and, where practicable, shall be returned unopened to the Bidder, accompanied by an explanation.

3.21 NOTIFICATION OF ADJUDICATION OF BIDDER & ADVERTISING OF RESULTS

3.21.1 Notification of the Adjudication of bid shall be in writing by a duly authorized official of Co-operative Governance and Tradition Affairs' Supply Chain Management unit.

3.22 PRO RATA DECREASE OF COMPENSATION

3.22.1 Should the services not be rendered to the satisfaction of the Department and unsatisfactory items/ aspects/ events have already, in writing, been brought to the attention of the Contractor, the Department reserves the right in terms of paragraph 3.27 hereunder, to retain payment to the Contractor for as long as the unsatisfactory service continues.

3.23 CENTRAL SUPPLIERS DATABASE

2.23.1 A bidder submitting an offer must be registered on the Central Suppliers Database. A bidder who has submitted an offer and is not registered on the Central Suppliers Database will not be considered. 3.23.2 Each party to a Joint Venture/Consortium must be registered on the Central Suppliers Database at the time of submitting the bid.

3.24 SUBMISSIONS AND COMPLETION OF SBD 6.1

3.25 TERMINATION OF SERVICES

SPECIFICATION

CONDITIONS OF CONTRACT

SECTION 1: DEFINITION OF TERMS

The following definitions of terms will apply in respect of this contract.

1. AGREEMENT

This comprises the agreement signed by the parties, the conditions of the bid, the bid and the accepted document, the agreement conditions and the specifications.

2. CONTRACT PERIOD

The period during which the service is to be rendered and originally determined in the agreement, or as amended, extended or renewed in accordance with the stipulations of the agreement.

3. CONTRACTOR

The person/s, partnership, closed corporation, firm or company, whose bid was accepted for this service.

4. CONTACT PERSON

The Department of Cooperative Governance and Traditional Affairs shall appoint an Official who shall be the contact person on all matters pertaining to this contract.

5. **DEPARTMENT**

The Department is the Department of Cooperative Governance and Traditional Affairs.

6. PARTIES

The Department of Cooperative Governance and Traditional Affairs on the one part and the Contractor on the other part.

7. SERVICE

The supply and delivery of emergency food parcels should be in terms of the scope of work for this contract.

In the inevitable circumstances of disaster, e.g. storms, floods, fires etc., the Department endeavours to provide those who have been affected, as a result of such disaster, with an emergency food parcel. This is until such time the incumbent and his/her family has managed to recuperate from and normalize their circumstances. As a means of meeting this need emergency food parcels are given to them in an effort to alleviate the disruption suffered by the incumbent.

The Department of Cooperative Governance and Traditional Affairs wishes to enter into a contract with a supplier, for a three (3) year period for the supply and delivery of emergency food parcels, as per the specifications in paragraph 3 below.

SECTION 2: NOTES AND CONDITIONS TO THE BIDDER

1. The Service Provider

The service provider to be appointed must fulfil the following requirements:

- a) Must have / operate a shop / supermarket / wholesale within the KZN province
- b) Must have all the items listed in the required contents of the emergency food parcel in the same shop / supermarket / wholesaler.
- c) Must have staff capability to package required emergency food parcel on the premises immediately
- d) Must have appropriate vehicles to deliver small, medium and large quantities of food packs
- e) Must have appropriate facility for packaging and storage of food items to ensure healthy food provision to the beneficiaries
- f) Must display capability and experience in handling large quantities of food supplies within shortest possible time after an order has been placed.

2. Samples and site visits

- a) The Department will organize with the shortlisted service providers a site visit to verify all the points on section 2 (1) above on the requirements, before final evaluation can be concluded.
- b) Should the need arise for the Department to do an evaluation of the emergency food parcel itself during the evaluation phase of the bid, the relevant suppliers will be contacted and requested to provide a sample of the emergency food parcel.
- c) Samples must be packaged independently of the bid document and must be clearly marked with the bid number, closing date and suppliers details, i.e. Company name, telephone number/s, contact person/s and address. Bidders will be advised when they can collect their samples after the evaluation has been finalized.

NOTE: This will only affect suppliers who have been short listed

3. Delivery:

- a) Food parcels are to be supplied, delivered and packed into the Disaster Management Store situated at the Disaster Management Centre, 66 Shorts-Retreat Street, Mkondeni, Pietermaritzburg.
- b) The delivery period must be within 24hrs from the time of placing an order and the service provider must be available to render these services during awkward times such as weekends, holidays and evenings.

c) In emergency situations the successful supplier may be called upon for an earlier delivery, i.e. in the event of a disaster. It must be noted that should the supplier not be able to meet the earlier delivery in an emergency situation, the Department reserves the right to approach another supplier to provide the Department with its requirements.

4. Delivery to District Municipalities :

- a) The Department will also reserve the right to instruct the successful supplier to deliver food parcels to assigned reception and storage areas in District Municipalities for further distribution by the designated personnel as will be determined by the PDMC.
- b) The supplier will therefore be required to provide a quotation for delivery to the specific area, other than the Provincial Stores, which will be subject to agreement by the Department for implementation thereof.
- c) A list of District Municipalities and addresses for reception and storage depots is attached as Appendix 4 for the ease of reference, and the service provider will only do so based on the instruction by the PDMC.

5. Contract

The successful Contractor will be required to enter into a contract with the Department of Cooperative Governance and Traditional Affairs. The contract shall take the form of a Memorandum of Agreement (MOA) in respect of the terms and conditions set and the services required.

6. Monitoring of Service

- (a) Representatives of the Department may at any time inspect the Contractors work and / or performance.
- (b) Should the Department consider the standard objectionable, the Contractor will be notified accordingly in writing and the Contractor shall cause the objectionable situation to be rectified to the standard required by the Contract Specifications within five working days of such notification, at his/her own cost and charge.
- (c) In the event of the Contractor disregarding such notification for a period of five (5) working days, the Department shall be at liberty to forthwith to employ other workmen to perform the work or cause the work to be performed, and
- (d) To charge any expense thereby incurred to the Service Provider, and to deduct it from any sum due or to become due to the Service Provider.

- 7. Should the Contractor fail to meet any conditions of this contract or continue rendering unsatisfactory service, the Department reserves the right to terminate the contract, after written notification has been served on the Service Provider, with retention of the right to recover from the Contractor any losses which the Department may have suffered/incurred as a result of the failure, without prejudicing any other rights it may have. The Department may also impose such penalties as provided in the SCM General Conditions of Contract.
- 8. As compensation for the services to be rendered by the Service Provider, the Department hereby agrees to and undertakes to pay the Contractor the amount as expounded in the contract.
 - (a) Payment shall be made within thirty (30) days from the receipt of an agreed invoice by the Department. Any query regarding late payments must be directed and addressed to the contact person.
 - (b) The bid price as originally determined, or possibly adjusted in terms of the applicable provisions of the contract, shall be applicable for the full duration of the contract period.
- 9. The prospective Contractor must state whether he/she has other current similar contracts and where these are, so that the standard of his/her work may be inspected.
