- 1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and visa-versa and with words importing the masculine gender shall include the feminine and the neuter.
- 2. Under no circumstances whatsoever may the bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4. Bids submitted must be complete in all respects.
- 5. Bids shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the bid documents.

- 7. All bids received in sealed envelopes with the relevant bid numbers on the envelopes are kept unopened in safe custody until the closing time of the bids. Where, however, a bid is received open, it shall be sealed. If it is received without a bid number on the envelope, it shall be opened, the bid number ascertained, the envelope sealed and the bid number written on the envelope.
- 8. A specific box is provided for the receipt of bids, and no bid found in any other box or elsewhere subsequent to the closing date and time of bid will be considered.
- 9. No bid sent through the post will be considered if it is received after the closing date and time stipulated in the bid documentation, and proof of posting will not be accepted as proof of delivery.

#### 3.21 NOTIFICATION OF ADJUDICATION OF BIDDER & ADVERTISING OF RESULTS

3.21.1 Notification of the Adjudication of bid shall be in writing by a duly authorized official of Cooperative Governance and Tradition Affairs' Supply Chain Management unit.

#### 3.22 PRO RATA DECREASE OF COMPENSATION

3.22.1 Should the services not be rendered to the satisfaction of the Department and unsatisfactory items/ aspects/ events have already, in writing, been brought to the attention of the Contractor, the Department reserves the right in terms of paragraph 3.27 hereunder, to retain payment to the Contractor for as long as the unsatisfactory service continues.

#### 3.23 CENTRAL SUPPLIERS DATABASE

- 2.23.1 A bidder submitting an offer must be registered on the Central Suppliers Database. A bidder who has submitted an offer and is not registered on the Central Suppliers Database will not be considered.
- 3.23.2 Each party to a Joint Venture/Consortium must be registered on the Central Suppliers Database at the time of submitting the bid.

#### 3.24 SUBMISSIONS AND COMPLETION OF SBD 6.1

3.24.1 Bidders are to complete SBD 6.1 document where applicable. Failure by the bidder to submit a valid B-BBEE status level verification certificate will result in the bidder not being considered for preference points allocation. If the information required is not applicable to the business, clearly insert the symbols "N/A" in the appropriate space. If the space provided is left blank, it will be regarded as information that is still outstanding and the SBD 6.1 will not be processed further.

#### 3.25 TERMINATION OF SERVICES

3.25.1 Should the Contractor fail to meet the conditions of this contract, or continue rendering unsatisfactory service, the Employer reserves the right to terminate the contract, after written notification has been served on the Contractor, with retention of the right to recover from the Contractor any losses which the Employer may suffer/ incur as a result of the failure, without prejudicing any other rights it may have.

#### 3.26 TAX CLEARANCE CERTIFICATE

- 3.26.1 The central supplier database and the tax compliance status pin are the approved methods that will be utilised to verify Tax Clearance compliance.
- 3.26.2 Each party to a Joint Venture/Consortium must submit the tax compliance status pin/ printed copies of tax compliance certificates together with the bid before the closing date and time of bid.

#### 3.27 UNSATISFACTORY PERFORMANCE

- 3.27.1 Unsatisfactory performance occurs when performance is not in accordance with the contract conditions.
  - (i) Before any action is taken, the Department shall warn the contractor by registered/certified mail that action will be taken in accordance with the contract conditions unless the contractor complies with the contract conditions and delivers satisfactory supplies or services within a specified reasonable time (7 days minimum). If the contractor does not perform satisfactorily despite the warning the Department will:
    - (a) take action in terms of its delegated powers
    - (b) make a recommendation for cancellation of the contract concerned.

# APPOINTMENT OF A PANEL OF SERVICE PROVIDERS TO BE APPOINTED TO RENDER CLOSE ARMED PROTECTION SECURITY SERVICES TO ADMINISTRATORS APPOINTED IN TERMS OF SECTION 139(1)(b)&(c) INTERVENTIONS

#### 1. BACKGROUND TO THE PROJECT

- 1.1 On an ad-hoc basis the KZN Provincial Cabinet resolves to intervene in the affairs of Local or District Municipality in terms of section 136 (Financial) or section 139 of the Constitution in respect of the Functions and Powers set out in section 51 of the Local Government: Municipal Systems Act, 2000 as amended.
- 1.2 An intervention may become necessary when the municipality cannot or does not fulfil an executive obligation in terms of the Constitution or legislation, the relevant provincial executive may intervene by taking any appropriate steps to ensure fulfilment of that obligation, including-
  - (b) Assuming responsibility for the relevant obligation in that municipality to the extent necessary to –
  - (i) Maintain essential national standards or meet established minimum standards for the rendering of a service:
  - (ii) Prevent that Municipal Council from taking unreasonable action that is prejudicial to the interests of another municipality or to the province as a whole; or
  - (iii) Maintain economic unity; or
  - (c) Dissolving the Municipal Council and appointing an administrator until a newly elected Municipal Council has been declared elected, if exceptional circumstances warrant such a step.
- 1.3 A Section 139 intervention would be resorted to where council do not exercise effective oversight over the administration and council decisions are negatively impacting on the finances and functioning of the municipality.
- 1.4 An Intervention may be extended by The Executive Council based on the rate of progress, poor capacity and outstanding challenges that are yet to be resolved as well as the lack of capacity to sustain progress and meet the objectives of the recovery plan that has been put in place.
- 1.5 For these reasons, once the Executive Council has resolved to intervene in a municipality, MEC for Co-operative Governance and Traditional Affairs is authorised to appoint his Representative/Administrator to undertake the functions assumed by the Executive Council.
- 1.6 On appointment the Administrator will report on a monthly basis on progress achieved, highlights the challenges as well as on outstanding targets in respect of the recovery plan put into effect at the commencements of the intervention. The recovery plan will eventually be translated into an exit plan on termination of the intervention.
- **1.7** Due to the nature of interventions and the continued instability in the affected municipalities it is necessary for IMMEDIATE urgent close armed protection services to be provided to the appointed Administrators for the period of the SECTION 139 interventions.

#### 2. OBJECTIVE

2.1 The objective of this panel of close armed protectors is to render close armed security services to appointed Administrators without delay should the Executive Council resolve to intervene in the affairs of Local or District Municipality in terms of section 139 of the Constitution in respect of the Functions and Powers set out in section 156 of the Constitution of the Republic of South Africa, 1996.

#### 3. DETAILED SCOPE OF WORK

3.1 The <u>project scope</u> is likely to include, inter alia, some or all of the following dependent on the nature of the intervention required:

#### TERMS OF REFERENCE FOR CLOSE ARMED PROTECTION SECURITY SERVICES

- 3.1.1 Protecting the Principal (Administrator) from threats such as criminal, political, stalkers or enthusiastic fans;
- 3.1.2 Threat and Risk Assessments e.g. planning travel and principal's engagements;
- 3.1.3 Being constantly alert to react to threatening situations;
- 3.1.4 Accompanying the Principal when traveling/on visits;
- 3.1.5 Specialisation in offensive and defensive driving techniques;
- 3.1.6 Specialization in residential security, private investigation techniques and surveillance and counter surveillance;
- 3.1.7 Experience in the field of un-armed combat and defense;
- 3.1.8 Excellent vision and hearing;
- 3.1.9 Strong physical shape;
- 3.1.10 Familiarity and knowledge of a wide range of weapons, both from an offensive and a defensive perspective;
- 3.1.11 Active thinking, critical analysis and communication skills;

#### 3.2 Institutional Arrangements:

The close armed protectors will be accountable to and under the direction of the Principal (Administrator assigned by KZN Department of Co-operative Governance and Traditional Affairs) in the performance of their duties.

3.3 The security service provider must submit monthly reports to the Acting Director: Security and Risk detailing progress being made, challenges encountered and highlighting any possible threats relating to the protection of the Principal.

#### 4. QUALIFICATION CRITERIA

Only service providers who meet the pre- qualifying criteria and administrative criteria will be considered.

- Two x close armed protectors from a registered security company will be required / allocated to each appointed Administrator/ Principal. (Provide the curriculum vitae of all their close armed protectors who must have SAPS fire-arm competency as well as driving experience.

- Security Clearance/ SAPS competency
- Valid driver's licence

### 5. EXPECTED OUTCOMES AND DELIVERABLES

- 5.1 Submit monthly security reports to the Department detailing threats, challenges and successes whilst rendering the services for each project.
- 5.2 There may be instances where the appointed Administrator or the close armed protection services may need to be replaced before the termination of the intervention.
- 5.5 The project is on an ad-hoc basis and appointment periods may vary depending on the duration of the Section 139 intervention.
- 5.6 The expected outcomes and deliverables will be determined on a project-by-project basis. All the required deliverables for each specific project will be determined based on the needs identified.

#### 7. MONITORING, REPORTING REQUIREMENTS AND PERFORMANCE MANAGEMENT

The service provider must submit detailed time sheets together with invoices and a monthly security report. Payment will be inclusive of the rates for 2 x closed armed protectors as well as their accommodation costs (Monday to Friday, dinner, bed and breakfast) should they be based some distance from home as well as for the vehicle hire to enable the protectors to travel from home to the intervention municipality on a Monday and return on a Friday. On an ad-hoc basis the Protectors will be required to accompany the Administrator out of the municipal area and over the weekends. It must be noted that the closed armed protectors will be traveling together with the Principal in his/her private vehicle during working hours. The security company vehicle will only be used by the closed armed protectors to get to work and back home.

#### 8. REMUNERATION
